TAKE NOTICE that the Council of the City of Chilliwack will hold a Council meeting, as noted above, on the following item:

## 1. **DEVELOPMENT VARIANCE PERMIT (DVP01138)**

**Location:** 8-7450 Huron Street

**Applicant:** Matt Leger, Cygnus Contracting


**Purpose:** To reduce the minimum required interior side lot line setback from 3.1m to 0m

within the R4-A (Medium Density Multi-Unit Residential) Zone, to facilitate the construction of a roof over an existing deck and to bring an existing deck within the subject property, as shown on the map below, into compliance with current Zoning

Bylaw regulation.

A Development Variance Permit was previously issued in 1994 for this property that reduced the minimum required interior side lot line setback from 6m to 4m along the eastern property line (DVP13/94). Due to a siting error during construction in 1997, a subsequent Board of Variance decision was issued for this property that further reduced the minimum required interior side lot line setback to 3.1m (BOV97/4).
