TAKE NOTICE that the Council of the City of Chilliwack will hold a Public Hearing, as noted above, on the following items:

Location: 46105 Princess Avenue

Applicant: Lookout Housing and Health Society

Purposes: To amend the 2040 Official Community Plan designation from "Residential 3" to "Residential 3a" as per the Downtown Land Use and Development Plan, to create a new R10 (Affordable Rental Housing) Zone and rezone the subject property, as shown on the map below, from a C2 (Local Commercial) Zone to a new R10 (Affordable Rental Housing) Zone, to facilitate the construction of an affordable housing apartment development to be maintained at below market rent.
