# ARE YOU ELIGIBLE?

In order to apply for the **Low-Flow Toilet Rebate Program** you must meet the following criteria:

- ⇒ Applicant must be registered property owner
- ⇒ Property must be on the City's water supply
- ⇒ Must be a single-family, detached house **OR** multi-family dwelling\* (townhouse or duplex) built prior to September 30, 2005
- ⇒ Toilet(s) being replaced must have a flushing volume of 13 litres or greater
- ⇒ New toilet must have been purchased and installed after April 6, 2010
- ⇒ New toilet must **not** be replaced as part of any construction activity requiring a building permit
- ⇒ New toilet must have a maximum performance rating (MaP) of 350 or higher
- ⇒ New toilet must **not** exceed 6 litres per flush

\* Multi-family (condominiums and apartments), industrial, commercial, and other non-residential properties are not eligible at this time.

\* Multi-family (townhouses and duplexes) and detached home strata are eligible; however, a **letter from their Strata Management Company or certified professional is required** stating that the current sewer system in its current orientation can in fact function with lower flows without detriment.

## MORE INFORMATION

### REPLACE YOUR WATER GUZZLING TOILET!

The City of Chilliwack has an excellent source of water from the Sardis-Vedder Aquifer. Using less water saves energy, saves money, and conserves our limited supply. To help us conserve water and sustainably manage this precious resource, the City of Chilliwack is offering a rebate of \$50 when you purchase and install a low-flow toilet to replace your water guzzling 13+ litre per flush (LPF) model. A low-flow toilet has a flush volume equal to or less than 6 LPF.

Most homes built before 2005 have inefficient toilets that waste water. In an average home, toilets represent 30% of indoor water use. Converting to a 6 LPF toilet can save between 80 and 100 litres of water per toilet per day. Save water and save money; there's no reason not to switch.

### DOES YOUR TOILET QUALIFY FOR A REBATE?

Look for a stamp on your toilet to find the number of litres per flush. It's printed on the inside or rear of the tank, on the tank label, which is on the top of the bowl, or on the flush valve. If you can't find a stamp, measure the tank to calculate the volume (length (cm) x width (cm) x water depth (cm) ÷ 1000 = volume in litres). If the flush volume is 13 litres (3.5 gal) or greater, it qualifies!

## WHAT YOU NEED TO DO:

1. Determine if you are eligible (refer to Eligibility Criteria on back)
2. Purchase your new low-flow toilet with a maximum performance (MaP) rating of 350 or higher. Submit your original sales receipt OR plumber's invoice.
3. Submit a photo of your new toilet(s) installed.
4. Dispose of your old toilet by:
  - Taking it to Bailey Sanitary Landfill (you are responsible for unloading your toilet). Your scale ticket is proof of drop off, so keep your scale ticket to obtain rebate;
  - Submitting a photo of the old toilet removed with the tank broken/severely damaged;
  - Or having your plumber write on the invoice that the old toilet was taken from the residence and disposed of professionally.
5. Mail OR bring your completed application form, original receipt, scale ticket and photos to:

To ensure your application will be processed, be sure you have completed the following:

- ◇ determined you are eligible for the rebate (refer to eligibility criteria);
- ◇ completed application form (all questions answered);
- ◇ signed and dated application (in space provided below);
- ◇ included original sales receipt (to be returned to you) or scan of the original, if emailing;
- ◇ included Bailey Landfill scale ticket or photo of old toilet removed with tank broken or plumber invoice stating toilet was properly disposed ;
- ◇ provided photo of new toilet in place.

Personal information on this form is collected under the authority of the Freedom of Information and Protection of Privacy Act, Section 33 (c) and will be used solely for the administration and evaluation of the City of Chilliwack Toilet Rebate Program as part of the Water Efficient Community Initiative. Participants may be contacted by survey for evaluation and water conservation program development.
