Jack gave a brief description of each submission, the committee discussed options and subsequently voted all in favour to accept #3 (fisherperson) for the main wall and #4 (salmon) for the wall below the overpass.

Jack estimated it might take 1-2 months to complete, and that the start time will likely be in the spring/summer so that the paint would be able to cure properly.

Carol provided the following updates:

Paramount lane is expected to be completed mid November.

Public art piece by First Nations will be installed at the Courthouse Plaza at the end of November.

The revised RFP for the Lickman roundabout is expected to be out by the end of November.

Discussion regarding the approval process for murals on private property to include the owners review and acceptance of the artwork earlier in the timeline. (Mural Festival)
