2. DEVELOPMENT VARIANCE PERMIT (DVP01155)



Valley Waste & Recycling Incorporated To permit the operation of a commercial truck parking and outdoor storage facility within the subject property, as shown on the map below. As the proposed use is not

within the subject property, as shown on the map below. As the proposed use is not permitted in the RR (Rural Residential) Zone, a Temporary Use Permit is required.

An application to vary the minimum screening, landscaping, and paving requirements of the Zoning Bylaw, to facilitate the proposed commercial truck parking and outdoor storage facility within the subject property, is being considered concurrently with the Temporary Use Permit application. The requested variances are as follows:

- to waive the minimum requirements for perimeter screening and landscaping of vehicular use areas;
- to waive the overall site landscaping requirements for industrial development;
- to reduce the minimum screening height requirements from 2.5m to 1.8m; and,
- to waive the paving requirements with respect to the off-street parking, maneuvering, access and egress, open storage, contractor's equipment, and vehicle storage compounds, which are currently surfaced with hard-packed gravel in lieu of asphalt, concrete or similar surface.



As a result of the public health emergency and resulting restrictions on public gatherings, public attendance at City Hall for Council meetings is not permitted at this time. Until this matter is resolved and the restrictions have been lifted, Council is not conducting public hearings regarding proposed Temporary Use Permits and Development Variance Permits. However, persons who deem that their interest in the property is affected by the proposed permits will have an opportunity to provide a written submission, **including your full name and address**, to the Corporate Services Department at 8550 Young Road, Chilliwack, BC, V2P 8A4 or by email to <u>clerks@chilliwack.com</u> no later than <u>4:00 pm on Monday</u>, <u>October 19, 2020</u>. All submissions will be recorded and form part of the official record of the meeting.
